Notice is hereby given that at this public meeting the business to be considered relating to La Salle County is solely for the purpose of conducting a Board of Directors meeting of the La Salle County Public Facility Detention Corporation Board. No business of the County will be discussed other than as it relates to the business of the La Salle County Public Facility Detention Corporation. No action on behalf of La Salle County will be taken at this meeting. Notice is given that members of the Commissioners Court may be present as Directors of the La Salle County Public Facility Detention Corporation and notice is given solely for the purpose of providing disclosure thereof.

**OPEN MEETING:** Discussion and action on the following matters concerning the La Salle County Detention Center facility in La Salle County, Texas, including: the financing; compliance with bond documents; operation and management of the Facility; and other matters related to the Facility, including but not limited to the following:

1. Call to order;
2. Verification of quorum present;
3. **EXECUTIVE SESSION:** *Consultation with Attorney*, a closed meeting will be held pursuant to Section 551.0725 for deliberation regarding contract negotiations where deliberation in an open meeting would have a detrimental effect on the Public Facility Detention Corporation's interests with a third party; and Section 551.071 of the Government Code regarding consultation with attorney to seek advice on pending and contemplated litigation, settlements, and other matters, which are confidential under the Disciplinary Rules of the State Bar, on which the duty of the attorney of the County under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Open Meetings Act, regarding the negotiation of legal responsibilities related to the financing and operation of the La Salle County Detention Center facility and the related revenue bond financing;
4. Consider and take action to authorize Joel Rodriguez as President of the LaSalle County Public Facility Corporation to execute the Design/Build Agreement and General Conditions relating to the LaSalle County Regional Detention Center Roof and issuance of notice to proceed;
5. Consider and take action to authorize Joel Rodriguez as President of the LaSalle County Public Facility Corporation to execute the Design/Build Agreement and General

Conditions relating to the LaSalle County Regional Detention Center HVAC and issuance of notice to proceed;

6. Report from legal advisor and/or Ira Cotler, Financial Consultant, relating to updates on the operation of the LaSalle County Regional Detention Center;
7. Adjournment.
